I am able to develop a range of services and I wish to become an EXCLUSIVE BUSINESS SOLUTIONS employee for my future missions. This is to be able to contract with my first client a mission in perfect accordance with the principles developed by the EXCLUSIVE BUSINESS SOLUTIONS group that I ask you to consider this prior recognition of my approach.

I understand that I will have to find these clients myself and negotiate my services under that you will set up and which specifies that the lower limit of the price excluding VAT a day worked is € 300 and that your intervention contract must be completed by me, signed by the client. Then, accepted by an authorized manager of the EXCLUSIVE BUSINESS SOLUTIONS group.

EXCLUSIVE BUSINESS SOLUTIONS pay me a guaranteed conventional salary, together with additional compensation linked to the achievement of my operating budget. Indeed, after deduction of the general expenses of EXCLUSIVE BUSINESS SOLUTIONS, up to 5 to 6% of the fees acquired (according to my operational operating choices) and deduction made of the operating expenses related to my activity, (including my conventional salary *), the balance of the account of my activity center will be acquired to me as "additional salary *". In agreement with my correspondent at EXCLUSIVE BUSINESS SOLUTIONS I can allocate this additional pay according to my development time and my intermissions in the context of a single accounting year.

I agree, upon signature of my contract of employment, not to perform services that are outside the professional liability coverage of EXCLUSIVE BUSINESS SOLUTIONS, which is the attached document that I sign, and you notify, in case of doubt, to obtain a formal agreement from you, prior to any engagement. I want, once my first client has been acquired, to look for other sources of assignments and for that, prospect in order to develop a clientele that will bring me significant and diversified income.

If I mention the name of the EXCLUSIVE BUSINESS SOLUTIONS group before signing my employment contract, I will do so in the conditional, so as not to suggest that I am mandated by the EXCLUSIVE BUSINESS SOLUTIONS group. I have noted that the signing of my employment contract can only intervene once a first service contract has been signed by EXCLUSIVE BUSINESS SOLUTIONS with my first client.
